Notice of U.S. Tax Information for U.S. Persons

As it is likely that Central GoldTrust ("GoldTrust") is a Passive Foreign Investment Company ("PFIC") for U.S. Federal income tax purposes, GoldTrust is providing the following information to its unitholders to allow them to make a Qualified Electing Fund ("QEF") election with respect to their investment in GoldTrust, should they so desire. PFIC ANNUAL INFORMATION STATEMENT

Unless specifically indicated otherwise, "PFIC" means Central GoldTrust.

This information statement applies to the taxable year of the PFIC commencing on January 1, 2009 and ending on December 31, 2009.

There were no distributions or deemed distributions to PFIC unitholders in respect of the December 31, 2009 taxation year.
